EMWD has completed work on a key facility that will help our region further prepare for future droughts!

EMWD's Mountain Avenue West Groundwater Replenishment Facility, located in San Jacinto, was finished in October, 2021. It received grant funding as part of the regional Santa Ana River Conservation and Conjunctive Use Program (SARCCUP), which is a first-of-its-kind regional groundwater banking program.

During years of wet or



normal rainfall, EMWD will import water from the State Water Project into the Mountain Avenue West basins. That water will enter into the local aquifer, where it will be available for use during years of drought.

This local water supply source will provide for tens of thousands of homes annually during dry periods, helping to ensure our customers a more reliable water supply future.

NEW MYACCOUNT FEATURES NOW AVAILABLE

Last month, EMWD debuted new customerfocused tools on the portal, which provides more resources to better manage your water use.

You can now sign-up for level-payment plans, transfer service from one property to another, and calculate water budgets. You can also sign-up for text or email alerts about billing, continuous usage warnings, water budget thresholds, and more. New analytics will help you compare historical water usage and better understand your water consumption in an effort to help save water and money.
